- #3 **Hayride Corn & Maze Package\*** - \$7 per person which includes hayride, corn maze & one 12U pumpkin patch pumpkin
- #4 **Hayride KidZone Package\*** - \$8 per child which includes hayride & one 12U pumpkin, and entrance into KidZone
- #5 **All - Inclusive Package\*** - \$11 per child which includes hayride, 12U pumpkin from the patch, corn maze, KidZone
